Patient Centered Care:

is patient driven healthcare delivered in a way that is focused on an individual patient's values and preferences and involves both sharing information and active shared decision making with patient, family/caregivers, and medical professionals to reach customized, individualized, and realistically obtainable goals of care. This is an ongoing process, keeping in mind these goals may changes over time.

- Information when I need it, how I need it
- Transitions of Care
- Good for Business # Good for Every Patient
- Metrics do not improve patient "performance"

What is the Reality?

- Living with a chronic illness is not unlike being in a long-term relationship
- It's not about you, it's about me

How Do We Bridge the Gap?


- Patient understanding and focus shifts as variables are introduced
- More stable = Less Risk Tolerant
- More unstable = More Risk Tolerant
- Leverage our story telling culture

Patient and Family Centered Care Meeting the Metrics of the QIP

- Patient engagement necessary to meet the QIP measures
- Patient and family involvement in the development of the POC vital to the facility meeting the QIP measures
- Patient and family engagement can help with patient adherence which translates into improved outcomes

- I want to be able to die with dignity
 - If the burden of my treatment outweighs its benefit, please help me to find a palliative care provider and a hospice provider



Conclusion

- QIP and Five Star are important, but are only a floor
- If we have a five star clinic without a QIP penalty, but then stop and do not look at ways to further improve care, we are not providing patient centered care

 - Medication Therapy Management
 - Nutritional education and counseling
